## **EMPLOYEE NEWS**



Free Kasasa checking refunds your ATM withdrawal fees, nationwide\*. So even if you get cash at one of the big banks' ATMs, we'll pay you back. No more searching for a "free" ATM.



Ask for free KASASA checking

«You will receive reimbursements for nationwide ATM withdrawal fees incurred within your Kasea Cash Back account during that Monthly Qualification Cycle when minimum qualifications are met. We reimburse ATM withdrawal fee, if you have not received an appropriate reimbursement, we will adjust the reimbursement amount if we receive the transaction receipt within skty (80) calendar days of the withdrawal transaction. When your Kaseas Cash Back account qualifications are not met, no cash back payments and nationwide ATM withdrawal fee are not will be credited to your Kaseas Cash Back account on the last day of the current statement cycle.



For just a small fee of \$25 per loan, you can choose to skip your November or December payment\*. The fee will not be added to the loan but can simply be transferred from your RiverFall Credit Union savings or checking account. If your payment is made through payroll deduction, it will be deposited into your savings account.

\*With approved credit, certain restrictions apply. Loan must be current and payments up to date. Fee increases to \$35/loan on requests that are received after the due date of the loan. Loan must be a minimum of 6 months old to qualify. Overdraft protection loans, mortgage loans, and credit cards are excluded.
